

# This Memorandum of Understanding

## 1. PARTIES

Prof. Rajendra Singh (Rajju Bhaiya) University, Prayagraj, Uttar Pradesh, established under the Uttar Pradesh Act, located at NainiCampus, Mahuwari, Prayagraj, 211009, Uttar Pradesh, INDIA (hereinafter referred to as 'PROF. RAJENDRA SINGH (RAJJU BHAIYA) UNIVERSITY'), which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors, executors, administrators and authorized assigns, on the First Part

AND

Uttar Pradesh Rajashri Tandon Open University, Prayagraj having its registered office at Shantipuram, Sector- F, Phaphamau, Prayagraj – 211021 (hereinafter referred to as 'UPRTOU'), which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors, executors, administrators and authorized assigns, on the Second Part.

Both shall herein after be collectively referred to as the "Parties" and individually be referred to as the "Party".

## 2. PURPOSE

2.1 WHEREAS 'UPRTOU' is interested in entering into Memorandum of Understanding (MoU) to promote international agreement, scholarly collaboration, cultural interaction and friendship by supporting educational, professional and cultural activities among faculty and students of the partnering institutions. Accordingly, the areas of co-operation will include, subject to mutual consent, any program offered at UPRTOU, as felt desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two 'Parties'.



WHEREAS PROF. RAJENDRA SINGH (RAJJU BHAIYA) UNIVERSITY is interested in collaborating with UPRTOU, to mutually explore, extend and strengthen a reciprocal relationship for promotion of professional education, research and capacity building by sharing the facilities and expertise available with both 'Parties'.

The specific areas of Collaboration between the two 'Parties' shall include the following:

- a) Joint Research activities
- b) Participation in Seminars/ Conferences/ Workshops etc. organized by either Party or both

- c) Organizing joint conferences/ seminars/ workshops etc.
  - d) Developing and executing special academic programs
  - e) Joint consultancies
  - f) Exchange of faculty members with prior consent of both 'Parties'
  - g) Exchange of academic material with prior consent of both 'Parties'

2.2 A Memorandum of Understanding (MoU) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time, but require the signatures of both Registrars or expressly designated delegates.

2.3 The purpose of this Memorandum of Understanding is to outline an academic framework between the two parties, designed to promote academic excellence at both institutions. The parties do not intend to be bound to each other, and this Memorandum of Understanding does not impose legal obligations on either party.

Every notice, request or any other communication required or permitted to be given pursuant to this Memorandum of Understanding shall be in writing and delivered either personally or sent by registered post or via courier or by e-mail (which shall be acknowledged by the other Party) to the Registrars of respective Parties at the address as stated below:


### 4. PUBLICITY AND ADVERTISING

### 5. DURATION OF MEMORANDUM OF UNDERSTANDING

5.1 This Memorandum of Understanding will be effective upon signature by each University's Registrar for a period of three years, at which time it will be reviewed for possible renewal for another three-year period.

5.2 Either party may, within sixty days written notice, terminate the Memorandum of Understanding in advance of its normal expiration or request the negotiation of its conditions.





**6. OTHER TERMS**

6.1 Any dispute or difference arisen out of this Memorandum of Understanding shall be resolved through amicable settlement.

6.2 Each party shall co-indemnify and hold each party harmless for any and all costs or expenses associated with damages or claims arising out of activities commenced under this Memorandum of Understanding, or any act or omission of the party, its employees or others acting on its behalf while undertaking any aspect of these co-operative activities.

6.3 This Memorandum of Understanding is in two originals, and both parties shall hold one original copy.
