### **III. RESPONSIBILITIES**

The parties to this 'Memorandum of Understanding' shall be responsible and accountable for the following responsibilities jointly and severally.

#### **III.A. JOINT RESPONSIBILITIES**


1. The parties shall be jointly responsible for proper and adequately scheduled enrollment, instruction and examination for the courses offered under this memorandum of understanding.

#### **III.B. RESPONSIBILITIES OF PARTY IN FIRST PART**

1. The party in FIRST PART shall be responsible to fulfill infrastructural, monitoring etc. requirements of the party in second part and/or students enrolled in the courses offered under this memorandum of understanding.
2. The party in FIRST PART shall be responsible to lead and facilitate joint organization of conferences, seminars, trainings, lectures, summer schools or such other events by whatever name called, in furtherance of the objectives of this memorandum of understanding.
3. The party in FIRST PART should share list of recommended students for 'Without Fee' (Pro-bono basis) as per course categories.

#### **III.C. RESPONSIBILITIES OF PARTY IN SECOND PART**



3. The party in SECOND PART shall be responsible to offer all such courses 'Without Fee' (Pro-bono basis) for recommended students of the university.

2. It shall be incumbent on the PARTY IN SECOND PART to utilize all personal and non-personal information of students enrolled in courses offered, strictly for the purposes of their training, examination and certification etc only.

2. This memorandum of understanding is merely 'expression of intent' of joint initiatives of the parties to this memorandum and the obligations under this memorandum shall not be legally enforceable by or against either of the parties.

This memorandum of understanding may be terminated at the instance of either party by providing an advance notice of 3 months with or without acceptance of such notice by the other party.
